

- NSBA lobbies for improvement to the maintenance of the navigation (dredging, moorings, tree clearance, river work) and presses for increases in funding for navigation priorities
- NSBA monitors the performance of the Broads Authority against its published programmes and objectives.
- NSBA stands firm against threats to close any part of the Broads navigation.
- NSBA works closely with national boating organisations to make sure issues important to Broadland are addressed in national debates.
- NSBA already represents 45 sailing and boating clubs and organisations together with more than 1000 individual members.
